# PUBLIC SERVICES REFORM (SCOTLAND) ACT 2010: STATEMENT FOR 2015/16

Under the Public Services Reform (Scotland) Act 2010 we have, along with other public bodies in Scotland, a duty to publish annual public statements relating to our expenditure in the following areas:

- Public relations
- Overseas travel
- Hospitality and entertainment
- External consultancy

In addition, the Act requires public bodies to publish details on:

- Payments with a value in excess of £25,000
- Employee/members who receive remuneration in excess of £150,000.

Furthermore, the Act requires public bodies to publish a statement of the steps it has taken during that financial year to:

- Promote and increase sustainable growth through the exercise of its functions
- Improve efficiency, effectiveness and economy in the exercise of its functions.

Our statement covering the financial year 2015/16 is set out below and includes Wave Energy Scotland costs established as part of Highlands and Islands Enterprise during December 2014.

# Efficiency, effectiveness and economy

HIE's Finance and Corporate Service team are constantly engaged in identifying opportunities to increase efficiency and lower costs whilst minimising impact on the business and improve service quality. In ensuring Block B (HIE's management and administration budget) remains on target, costs must be contained and inflation absorbed. In the current year (2015/16) the team identified net savings amounting to £0.25m through detailed focus on accommodation and utility costs incurred by HIE.

Improvement in efficiency and effectiveness can be demonstrated in that the savings contributed towards absorbing annual inflation and pay pressures as the HIE management and administration costs have reduced over the last 6 years by £3 million (17%).
